### 4. Qualifications of Exhibitors

The exhibitor must be the company which legally registered under applicable law for at least 3 years (including 3 years) in other nations or regions outside Chinese Mainland. The exhibitors must provide copy of certificate of incorporation or other valid documents for certification.

### 5. Application Procedures

a. Fill in the application form, mail or fax it to expo secretariat with official stamp and signature. The application deadline is December 31<sup>st</sup>,2011.

b. The exhibitor shall pay 30% of the exhibition fee as the down payment within 15 days after receiving confirmation letter from expo secretariat (payment deadline: January 20, 2012). The balance shall be paid before February 28, 2012. Otherwise, expo secretariat won't reserve the stands applied by the exhibitor.

c. The expo secretariat will get booth assigned after receiving the down payment and send Exhibitor Manual and Floor Plan to the exhibitors.

d. The exhibitor makes reservation of expo services according to Exhibitor Manual.

e. The exhibitor registers, installs booths and exhibits.

### 6. Confirmation and Payment

a. If exhibitor cancels the pre-booked booth or exhibiting space whatever the reason is, the down payment or total rental fees would not be refundable. The booth will be reassigned.

b. The exhibitor must not transfer his assigned booths or exhibiting spaces partially or wholly in any way to a third party. Otherwise, the-

-expo secretariat has right to remove his exhibits and cancel its participation.

The exhibitor who transfers the right of booth use or the rented furniture shall be responsible for any consequences and financial loss affecting any party.

c. Under special circumstances, the expo secretariat has reserved power to reassign booth, change booth layout and alter booth standard size. The exhibitor must not cancel the contract or claim for indemnity out of these reasons mentioned above.

#### **7. Regulation of Intellectual Property Right**

In order to protect the legal rights of the exhibitor, all samples on display shall be specified about their intellectual property rights. The exhibitor must obey China's Patent Law, Trademark Law, Copyright Law, other laws and regulations about intellectual property rights and other relevant regulations

about international intellectual property right agreements that China is involved in. The expo secretariat has right to remove its exhibits and suspend its participation if the exhibitor is found to exhibit infringing or counterfeit products.

8. This application form shall come into effect when it is signed by legal representative of the exhibitor and sealed.

9. Power of interpretation of this regulation all reserves to the executable unit of the expo.

10. All disputes arising from the execution of this regulation or related to it shall be submitted for arbitration to the China International Economic and Trade Arbitration Commission and the current rules of this Commission shall be applied. The award of the arbitration shall be final and binding upon both parties.
